




### CAMC Memorial Hospital Map:

### Directions to WVU—Charleston

#### From the North

Traveling either on I-77S or I-79S, drive until reaching the I-64E/I-77S split. Pick up I-64E/I-77S in Charleston and get off at exit 98 (35th Street Bridge). Once across the bridge, make a right at the light onto 61N (Mac-Corkle Ave.) Drive west until reaching the next light at the intersection of MacCorkle Avenue and 31st street. Turn right at the first light onto 31st Street. The Robert C. Byrd Health Sciences Center of West Virginia University Charleston Division (i.e., the WVU Building) is in the second block on the right corner, across from the CAMC employee parking garage.

### From the East

Drive I-64W/I-77N into Charleston, Take exit 95 (MacCorkle Ave. West) onto route 61N. Travel approximately 2.8 miles to 31st Street. Turn right at the light onto 31st Street. The Robert C. Byrd Health Sciences Center of WVU Charleston Division (i.e., the WVU Building) is in the second block on the right corner, across from the CAMC employee parking garage.

#### From the West

Drive I-64E/I-77S into Charleston. Get off at exit 98 (35th Street Bridge). Once across the bridge, make a right at the light onto 61N/MacCorkle Ave. SE. Drive west until reaching the next light at the intersection of MacCorkle Ave. S.E. and 31st Street. Turn right at the light onto 31st Street. The WVU Building is in the second block on the right corner, across from the CAMC employee parking garage.

### Introduction



According to research from the U.S. Department of Education, only 12 percent of English-speaking adults in the U.S. have proficient health literacy skills. The overwhelming majority of adults have difficulty understanding and using everyday health information that comes from many sources. including the media, websites, nutrition and medicine labels, as well as, from health professionals. According to HHS Secretary Kathleen Sebelius "Health literacy is needed to make health reform a reality. Without health information that makes sense to them, people can't access cost effective, safe, and high quality health services." Health literacy is a major problem in WV; therefore, the WV Geriatric Education Center is committed to the education and training of faculty, practitioners and those who care for older adults to improve their knowledge of health literacy and their ability to teach and utilize health literacy.

Health Professionals including physicians, nurses, pharmacists, and social workers, who care for and interact with older adults about their health.
